# Ten Keys to Successful LIMS Deployment

It's All in the Planning



o get the most out of your laboratory information management system (LIMS) and laboratory automation investments, it is important to follow a few key guidelines in the selection and implementation process.

#### 1. Develop a Project Plan

"A plan is a list of actions arranged in whatever sequence is thought likely to achieve an objective." — John Argenti, author and founder of the Strategic Planning Society.

Before the project begins, an outline should be drafted that includes the major steps that need to be taken. Start by identifying the team of people who can take responsibility for addressing each challenge. Next, create a budget, estimate the time allotted for each milestone to be completed, and cre-



ate a vision of the implemented solution. It is important that the automation solution is selected to integrate with other unrelated organizational programs so that laboratories can leverage the Information Technology (IT) team's expertise and existing infrastructure. The plan should include the





time, scope, performance and cost of the project.

#### 2. Create a Laboratory Automation Project Team

To ensure that the major aspects of a LIMS solution are addressed, it is important to assemble a multi-disciplinary team that consists of the minimum number of core stakeholders. The team should include a member of laboratory management, an IT representative and a senior laboratory member. This team can be extended; however, it is often more efficient to keep the team small and focused. The team will develop a list of system requirements and compromises will have to be made, as there will be competing requirements for what the automation solution is required to do. The team will have to weigh each requirement and determine which has the greatest return on investment to the entire laboratory, not just one group or department.

#### **3. Solicit Team Buy-In**

The LIMS project team will lead the automation efforts, but it is very important to solicit feedback from all users so that they feel their requirements were also considered, evaluated and addressed. Because the deployment of a LIMS is typically an enterprise deployment, all end users must be included in the project since the laboratory automation goals will impact their job responsibilities and ultimate project success.

#### 4. Select a Solution Partner, Not Just a Vendor

Because the purchase of a LIMS is a long-term investment, there will be follow-up support contracts, product upgrades, training courses and new regulatory requirements. It is important to have a supplier that will continually update their product offerings, leverage new technology enhancements, meet changing regulatory requirements, solicit user feedback and provide high-quality technical support. A LIMS implementation requires a team approach and as such, the team chemistry is critical to the success of the project.

Supplier credentials such as ISO 9001:2000 Certification are equally important. Many companies require that they only purchase products from suppliers that also have an audited quality management system in place. In addition to certifications, prospective clients should consider the firm's understanding of industry needs, reputation, number of years in business, the technology platform, ability to meet the client's laboratory automation specifications and plans for upgrades.

#### 5. Examine Processes

Before a LIMS is deployed, conduct a needs assessment to define the project scope.1 Seek an external consultant, as they can be more objective and will ask questions that would not be asked internally. Many vendors offer a needs assessment service prior to the LIMS installation, since they are familiar with their technology and have subject matter experts that specialize in reviewing laboratory operations and procedures. The vendor will interview staff with a checklist of key questions, create flow charts of current operations, and then analyze current practices and question key processes. The end product is a report of the findings that includes flow charts, staff interviews and a laboratory automation requirements document. In addition, the laboratory may also want to consider validation requirements as a part of the project scope.2

#### 6. Utilize a Project Management Approach

The key elements in project management are people, systems and tools. Project leaders need to be identified, coached and trained. Adequate project resources must be allocated to ensure success. Elements of project management include publishing checklists, dashboards, Gantt charts, goals and expectations. Common tools include Microsoft Project, Visio and other packages that can track progress and project milestones.

#### 7. Evaluate and Leverage Best Practices

There is a fine line between cutting edge and bleeding edge. As a result, most laboratories use only robust technologies, as they cannot afford downtime to correct new technologies that meet their needs. There are many well-established automation technologies that will provide immediate payback when integrated with a LIMS, such as bar-coded label printing and scanning to import sample information, instrument integration, and secure Web portals where customers can retrieve their data and reports 24 hours a day, seven days a week.3 An underlying benefit of quality laboratory automation solutions and LIMS is enhanced data quality.4

#### 8. Align Technology with Your Business Objectives

If laboratories buy piecemeal proprietary solutions to solve one problem at a time, they will end up with an integration nightmare. It is important to select the proven technology for the specific challenge that is being addressed. For example, if *continued on page 30* 





continued from page 15 a laboratory requires a secure Web portal to allow customers access to LIMS data, they will need to ensure that the solution is compatible with the Internet browser that their clients are using. For security, they will also need to encrypt data that is accessed by their clients on the Internet because deploying the wrong technology or the correct technology improperly can have detrimental consequences on a laboratory's business.

#### 9. Embrace Continual Training

Customers typically use less than 50% of the capabilities of any LIMS they have implemented. Often this is because they buy a system based on the core functionality and are unaware of other benefits that could be realized. Originally trained users move to other positions and new users receive limited training. Training is critical to allow customers to realize all of the features of the LIMS. Many users are comfortable with core functionality and do not investigate what other features would benefit the laboratory.

#### 10. Continually Update the System

It is important to monitor LIMS progress and look for areas of additional improvement. With the LIMS in place, managers can extract real-time metrics that can be used in analysis and continual process improvement. Systems constantly need to be evaluated to determine when the return on investment is substantial enough to justify upgrades, since the new technology will

#### Summary

An integral part of any successful project launch is planning and teamwork. This should involve the proper team members, obtaining shareholder buyin and selecting the appropriate technology. Refusing to make any changes just because "that's how we've always done it" and, conversely, trying to revolutionize the whole technical strategy at once, will not propel the laboratory operation to new heights. Changes should be considered only after careful analysis, and the team must embrace change for the deployment process to be successful.
